Several of our captains participated in a command training with the Bozeman Fire Department on September 13th. 1. THE PARTIES. This Land Use Rental Agreement ("Agreement") made this 8/1/22 is between:

Land Owner: Hyalite Rural Fire District with a mailing address of 4541 S. 3rd Road. Bozeman, MT 59715 ("Land Owner"), AND

Tenant: Mountain Hot Tub 8488 Huffine Lane. Bozeman, MT 59718 ("Tenant").

Land Owner and Tenant are each referred to herein as a "Party" and, collectively, as the "Parties."

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual promises and agreements contained herein, the Tenant agrees to rent usage for employee parking on the Premises from the Land Owner under the following terms and conditions:

2. AGREEMENT TYPE. This Agreement shall be considered a:

- Month-to-Month agreement. The Tenant shall be allowed to park on the Premises on a month-to-month arrangement starting on 8/1/22 and ending upon notice of 30 days from either Party to the other Party ("Agreement Term").

3. PURPOSE. The Tenant may only use the Premises as:

- Employee Parking

4. THE PROPERTY. The Land owner agrees to lease the described property below to the Tenant:

- a) Physical Address: 5370 Gooch Hill Road. Bozeman, MT 59718
- b) On the north end of the lot, unimproved open field, north of the field driveway approach

5. RENT. The Tenant shall pay the Land owner, in equal monthly installments, \$500.00 ("Rent"). The Rent shall be due on the 1st of every month ("Due Date") and paid under the following instructions:

- Mailed or hand delivered to the Hyalite Rural Fire District, 4541 S. 3rd Rd. Bozeman, MT 59715

6. LATE FEE. If Rent is not paid on the Due Date:

- There shall be No Late Fee if Rent is late.

7. SECURITY DEPOSIT. As part of this Agreement:

- The Land owner does not require a Security Deposit as part of this Agreement.

8. EARLY TERMINATION. The Land owner or Tenant:

- Shall have the right to terminate this Agreement at any time by providing at least 30 days' notice.

9. SUBLETTING. The Tenant shall not be able to sublet the Premises.

10. MAINTENANCE, REPAIRS, OR ALTERATIONS. The Tenant may not make any alterations to the leased premises without the consent of the Land owner. The Tenant shall be responsible for snow removal or mowing in order to maintain a parking area as needed.

11. COMPLIANCE WITH LAW. The Tenant agrees that during the term of the Agreement, to promptly comply with any present and future laws, ordinances, orders, rules, regulations, and requirements of the Federal, State, County, City, and Municipal government or any of their departments, bureaus, boards, commissions and officials thereof with respect to the premises, or the use or occupancy thereof, whether said compliance shall be ordered or directed to or against the Tenant, the Land owner, or both.

12. DISPUTES. If a dispute arises during or after the term of this Agreement between the Land owner and Tenant, they shall agree to hold negotiations amongst themselves, in "good faith", before any litigation.

13. INDEMNIFICATION. The Land owner shall not be liable for any damage or injury to the Tenant, or any other person, or to any property, occurring on the Premises, or any part thereof, and the Tenant agrees to hold the Landlord harmless from any claims or damages unless caused solely by the Land owner's negligence.

Proposal for purchase of used ambulance (A-6-2)

Purpose:

The purpose for the purchase of a used ambulance would be to expand our ambulance transport capabilities. As well as give us the capability to have a reserve ambulance in our fleet. As the fire district continues to develop and increase in population, the need for ambulance transport services will continue to increase. The opportunity to purchase this ambulance would be a great cost savings to the Hyalite Fire District.

Proposal:

The Hyalite Fire District has the opportunity to purchase a used ambulance from the Central Valley Fire District. We currently own and operate two ambulances. Ambulance 6-1 which is a 2021 Ford Transit type 2 ambulance, purchased in 2021. Ambulance 6 which is a 2000 Ford F-450 type 1 ambulance which we purchased used from the Big Sky Fire District in 2010. Ambulance 6 is approaching 175,000 miles on the vehicle and has experienced some mechanical issues given its age and use. Ambulance 6 is still in usable condition and would fit the need as a reserve status ambulance. The opportunity has arisen to purchase a used ambulance at a significant cost savings compared to the current used ambulance market. The ambulance Central Valley has for sale is a 2005 Ford F-450 type 1 ambulance built by Wheeled Coach. The ambulance has 72,000 miles on it and has no current mechanical issues. The ambulance had an engine replacement done in 2016. The new engine has approximately 28,000 miles on it.

Ambulance 6-1 is the primary use ambulance out of the Sourdough Fire Station. Ambulance 6-1 is used for transports during the day on weekdays and day and night on weekends. Ambulance 6 is out of the Cottonwood Fire Station and used for transports weekdays at night. Given we currently operate two ambulances out of two different fire stations, we do not have a reserve ambulance. If we were to purchase this used ambulance it would give us the opportunity to move ambulance 6 to a reserve status as a backup to ambulance 6-1 and the new ambulance 6-2. This purchase would hopefully buy us a little more life in our ambulance fleet before we need to look at another new

ambulance. Placing the Ambulance 6 as reserve at the Rae Fire Station would also give us the opportunity to utilize an ambulance for EMS calls out of Rae station and save wear and tear on our fire engines.

The Central Valley Fire District is offering to sell the ambulance to the Hyalite Fire District for \$10,000.00. This price is well under the current market value for used ambulances which starts around \$25,000.00 for a vehicle with significantly higher miles in the range of 250,000 and above. The purchase price to get this ambulance into service would be -

\$10,000.00 Purchase price from the Central Valley Fire District.

\$ 2,400.00 Installation of the cot.

\$ 4,500.00 Cost to reapply decals to the exterior.

\$ 1,500.00 Cost to install radios.

Total project cost - \$18,400.00

1. The Hyalite Fire District has responded to 463 calls as of October 1st 2022.
 - Call volume as of October 2021 - 474
 - Call volume as of October 2020 - 426
 - Call volume as of October 2019 - 395
2. Our current roster is at 46 members (effective 10/1/2022).
3. We currently have 6 resident firefighters living at the Sourdough Fire Station.
 - Sourdough resident firefighters continue to fill weekend shifts Friday 7pm – Monday 7am
 - We had two firefighters leave the Sourdough Resident Program in September. Conner Killeen relocated to Grand Junction, Colorado after graduating from MSU this spring. Juliette Moore has taken a nursing position in Grand Junction, CO after graduating this spring from MSU.
 - We are in the process of bringing two new resident firefighters into the Sourdough Resident Program. Ted Yewer and Tyler Newell will be moving into Sourdough this month. This will bring our staffing of Sourdough residents back to eight.
4. We currently have 4 resident firefighters living at the Cottonwood Fire Station.
 - Cottonwood resident firefighters continue to fill weekday night shifts Monday – Thursday 7pm – 7am.
5. We currently have 4 resident renters at the Rae house.
 - Alex Phillips will be moving out of the Rae House this October after a job change. Alex will remain a member of the Fire District. Andrew Sprague will be moving in to take the open position.
 - Rae renters continue to be offered incentive in discounted rent for responding to 30% of the call volume per month.

6. In the course of 2022 so far we have had four of eight residents move out of the Sourdough Fire Station. One resident moved out of Cottonwood and one moved out of the Rae house. We have been able to refill the six vacancies with members of the fire district almost immediately. I believe it speaks volume of the success of our resident program and the interest from our volunteers.

7. Non-resident volunteer firefighters continue to cover 6 hour shifts at the Sourdough Fire Station on Monday – Friday 7am – 7pm. This staffing level allows us to keep a crew on duty at the fire station 24 hours a day, 7 days a week.

8. We continue our regular multi company fire and EMS training every Wednesday night and command training twice a month.

9. Our fall firefighter recruit academy is well underway. Captain Malone got the academy started at the beginning of September. We brought on six new firefighters. The academy recently completed their first round of testing with MSU Montana Fire Services Training School. All members successfully completed their first testing for Firefighter 1 certification.

10. Several of our Captains participated in a command training hosted by the Bozeman Fire Department on September 13th. It was the first mutual aid command training a department besides Hyalite has hosted in several years. We hope to see it become a regular event.

11. Captain Malone has been participating in coaching the Gallatin Valley Fire Academy which consists of new recruits for the three career fire departments (City of Bozeman, Central Valley Fire District & Big Sky Fire District) in Gallatin County. Malone's participation is helping keep training standards and similar operating procedures with our mutual aid partners.

12. Fire Chief Nickolay, Lieutenants Templeton and Filce attended the State of Montana Fire Convention in Butte, MT on October 6th - 8th. The convention is put on by the Montana State Fire Chiefs Association. All participants got a lot out of the training and networking opportunities. A lot of what was received was validation that the Hyalite Fire District is properly training and caring for our members.

13. Fire Chief Nickolay deployed with the MT DNRC County Assist Team to the Murray Fire outside of Drummond, MT. Chief Nickolay filled the role as a task force leader for the incident. The deployment was September 6th - 14th. Staffing for Hyalite was not affected. We were able to utilize the DNRC backfill model to fill shifts I was absent from. Backfill allows our paid staff to fill in on overtime which will be reimbursed by the DNRC.

14. Hyalite Fire participated in a county wide active killer training on October 5th at the Sacajawea Middle School. The training was put on by Gallatin County Emergency Management. The purpose of the training was to practice the rescue task force model being adopted by agencies in Gallatin County. Nearly all the law enforcement agencies and several fire departments participated in the training. Assistant Chief Dahlhauser helped with the planning and execution of the training from the fire and EMS side. - Issues with EPCRs through Emergency Reporting have been resolved.
- We have been actively transporting patients with our ambulances in the past month. We should expect to see collections from these transports. A monthly detailed report of transports will be included in further chiefs reports.

19. We have experienced no firefighter injuries in the last month.

20. Engine 6-2 annual pump testing in September. Captain Prato looked into the issue and found an issue with the pump transmission driveline. Extensive repairs to the pump and transmission have been performed by Captain Prato. Engine 6-2 is back in service with limitations as we are waiting for Big Sky Fire Equipment to come back and re-pump

test. Captain Prato was able to complete the repairs with the training he received at the Waterous Pump school he attended last year. Engine 6-2 was out of service from September 7th until October 13th.

21. All Hyalite Fire apparatus are in service.

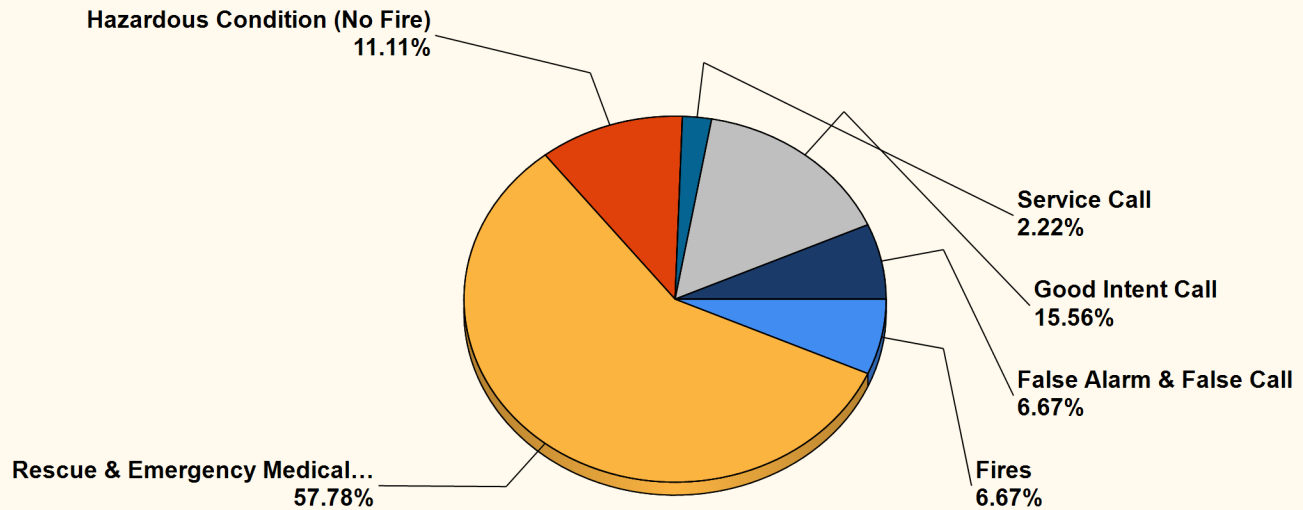
